### **INTRODUCTION**

Prospects for the development of non-governmental education in Uzbekistan

Non-governmental educational organizations operate under a license.

Non-governmental educational organizations provide educational services in accordance with the requirements and conditions of the license.

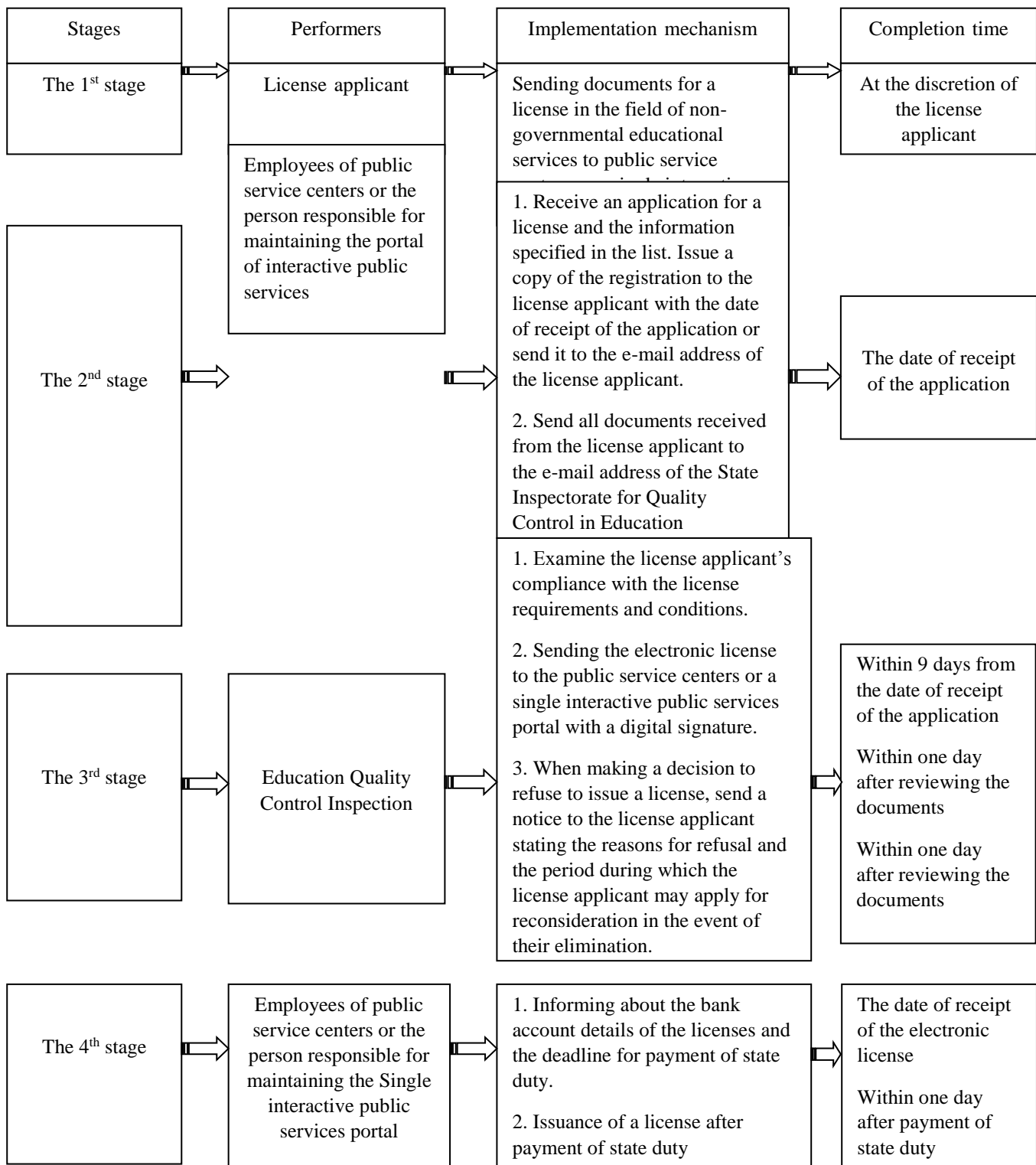
Non-governmental educational institutions that provide educational services in accordance with state educational standards and state educational requirements provide graduates with state-approved educational documents.

Non-governmental educational organizations that provide educational services on independently developed and licensed curricula provide graduates with documents on education recognized in the Republic of Uzbekistan.

Non-governmental educational organizations will take measures to create the necessary conditions for the organization of the educational process in accordance with the requirements of the normative legal acts and to attract highly qualified teachers and other personnel.

Curricula developed by non-governmental educational organizations shall be based on the terms, conditions and conditions of training established between the student or his / her parents or other legal representatives and the non-governmental educational organization. The law of the parties and on the basis of a contract that sets out obligations and other conditions. The main directions and tasks of further development of non-governmental educational services in our country are:

- creating a conducive environment that ensures a high quality of education by identifying and supporting gifted children and talented youth;
- accelerate the development of a market for paid educational services, which will create alternative opportunities for quality and popular education, along with traditional educational services, to create a healthy competitive environment;
- increase the efficiency and effectiveness of education through the use of innovative pedagogical forms, methods and modern technologies, taking into account the best international practices.

**Licensing of non-governmental educational services Scheme**

**LEGAL ENTITIES ENGAGED IN THE ACTIVITIES OF NON-GOVERNMENTAL EDUCATIONAL SERVICES**

- carries out its activities in accordance with state educational standards and requirements;
- take measures to provide highly qualified teachers and other personnel, to create the necessary conditions for the organization of the educational process, in strict compliance with applicable laws and regulations;

-interacts with the parents or other legal representatives of the students in accordance with the agreement, which stipulates the terms and conditions of study, the amount of payment, the rights and obligations of the parties and other conditions;

-finances its activities from the provision of paid educational services to the population, funds from charitable foundations and grants, as well as other sources not prohibited by law; issues state-issued education certificates to graduates.

Legal entities providing non-state educational services in the field of preschool and general secondary education provide educational services to gifted and talented children from families in need of social protection in the amount of not less than 10% of the total number of students in the institution. Free (on a grant basis) enrollment at the expense of income received in return. The decision to continue the free (grant-based) education of students in subsequent years is made by a legal entity engaged in the provision of non-governmental educational services, based on the family situation of the student and his academic results .

There are a number of tax and customs benefits for non-governmental educational institutions in the country: First, legal entities engaged in the provision of non-governmental educational services in the field of preschool and general secondary education until January 1, 2025. Exempt from the following fees:

- Exemption from all types of taxes and mandatory payments to the state trust fund (except for VAT), including the release of funds to equip them with modern teaching aids, purchase of necessary products and equipment, reconstruction of buildings and structures, capital investment. targeted education and the provision of free educational services to vulnerable groups;
- A single social payment for the monthly work of foreign teachers and specialists involved in the educational process on the basis of an employment contract.

Second, modern teaching and laboratory equipment, computer hardware, software, educational and scientific-methodical literature, inventory and logistics, which are not produced in-house and imported to equip and operate non-governmental educational institutions. Resources will be exempt from customs duties (excluding fees for customs clearance) until 2025.

Third, multiple-entry visas for foreign teachers and specialists and their families, as well as temporary residence permits in Uzbekistan, will be issued and extended without paying state duties.

Permits for attracting foreign teachers and specialists to our country, certificates of the right of these citizens to work are issued by the Ministry of Labor on the orders of the Ministry of Public Education.

Fourth, the Ministry of Public Education may file complaints alleging violations of the rights and freedoms of secondary school teachers in the course of their professional activities without paying state duties.

It should be noted that the full list of entities exempt from paying state duties in the courts is provided in Articles 329 and 330 of the Tax Code.

## CONCLUSION

It should be noted that improving the activities of non-governmental educational institutions and strengthening the legal framework for their full functioning will contribute to the further development of education in our country.
