The pamphlet entitled, '*Miscegenation: the theory of the Blending of races, applied to the American White man and Negro, published in December 1863.*' The myriad terms are used to describe the phenomena of race mixing. The multiple terms are coined the hybridization, mestissages, mono-realization, bio-culturalism, and many others. The word *mestizaje*, *mesticagem*, and *mestissage* are used in *Spanish*,

Portuguese, and French to describe the mixing of races. These words are used in archaic than miscegenation. The word *mestizo* borrowed from Latin language "*mixticius*" means 'mixed people'. The word '*mixticius*' borrowed from Spanish "*mestizo*". This word also used by the *Portuguese* "*miscegenacao*". Miscegenation is a cover term for all phenomena of mixing related to race and culture. It can be used in reference to biology, aesthetic, culture, society and politics etc. It is a consequence of migration and attraction of the upper caste people. Miscegenation is not an actual practice of interactivity. Migration frequently found in encounters of people in contact zones.

The term miscegenation originated in 1860 and referred to the "mixture of two or more races".
